

Tuition and Fees Information 2026-2027

REQUIRED FEES:

- **Non-refundable Registration Fee-** \$160 per student (\$480 max) due at registration
- **Activity Fee-** \$100 (K-8) per student due at Packet Day
- **Technology Fee-** \$125 per student (\$375 max) due at Packet Day
- **Kindergarten Supplies-** \$88 per kindergarten student due at Packet Day

TUITION PAYMENT OPTIONS:

- one payment– (no fee added) due July 26 & 27 (Packet Days)
- per semester– (2 payments, 2% added to tuition total) FACTS Tuition
- per quarter- (4 payments, 3% added to tuition total) FACTS Tuition
- monthly- (10 payments, 5% added) FACTS Tuition
